### **Private Interest Foundation and International Business Corporation**

A Panamanian Private Interest Foundation is a not-for-profit foreign juridical entity that allows you to transfer real, personal, and liquid assets away from the jurisdiction of your home country, without setting off any government or regulatory notices. You maintain absolute control over the activities of a PIF, though your name does not appear anywhere in the public record, thereby maintaining your privacy and anonymity. A PIF eliminates probate, inheritance and other taxes, and statutory regulation.

An International Business Corporation allows you to conduct business and for-profit activities anywhere in the world. Your PIF holds all of the shares in the IBC. This gives you direct legal control over the activities of the IBC, though your name does not appear anywhere in the public record.

### **Foreign Bank Account**

You can set up banking for a PIF and/or IBC, thereby allowing you to easily move funds out of your home country. We can even set up an investment account that allows you to hold funds in alternative currencies to U.S. dollars.

### **Pure Trust Organization**

A Pure Trust Organization is a common law unincorporated contractual organization, which is immune from statutory jurisdiction and regulations. A PTO can hold any kind of property. It is especially useful for real property, vehicles, and businesses. No claim against you can result in an attachment of property held in a PTO. You are completely free from liability as a result of the activities of a PTO, and vice versa.

### **Limited Liability Company**

A Limited Liability Company is a statutory artificial entity that can be used for any activities that are within statutory jurisdiction. An LLC must keep records and file an annual tax return. However, by establishing an IBC as the owner of an LLC, your name does not appear anywhere in the mix. Using a combination of LLC, PTO, PIF and IBC, you can create an impenetrable fortress around your property and business; one in which you hold no liability while maintaining absolute control. This is the ideal asset protection structure.

### **Custom Communications Security**

### **Declaration of Intention**

A Declaration of Intention is a statement that you do not subscribe nor give allegiance to the statutory United States (or another country). It allows you to sever any presumed relationship you may have with statutory authorities. This document is recorded on a county level.

### **Preferred Client Program**

This documentation voids out the issuance of a SSN, retroactive to the date it was originally assigned to you. Once complete, you are no longer required to pay income and social security taxes. However, you are also no longer eligible for federal benefit programs (Social Security, Medicare, etc.).

### **County Sovereignty Papers**

Once you have rescinded your SSN, it is recommended that you have Sovereignty Papers recorded with your county. These papers add another level of protection to your position outside of statutory jurisdiction.

### **Common Law Lien**

A common law lien is placed on property over which the lienor has legal possession. It does not require a court proceeding and it cannot be removed for 100 years, even by a statutory court order. Like all liens, it freezes title so that nobody can seize the lien property without first paying the amount of the lien.

### **Credit Card Debt Elimination**
